Persons are invited to submit comments in writing on the agenda items and/or attend and make comment on that item at the Board meeting.

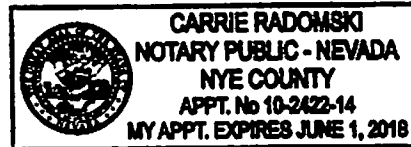
