a. Presentation – Information and discussion about Railroad Locomotive available through donation from the Nevada National Security Site (Nevada Test Site). – Robert Johnson

Robert Johnson – Explained that while the locomotives themselves have no cost, as they are potential donations, there would be cost associated with the relocation of them.

Mr. Johnson - Recommended a trip to the Test Site to view them; if there is interest a committee could be formed to approach the Nevada National Security Site to begin discussions about the details of the possible donation.

Mr. Johnson - Requested that anyone interested in viewing the locomotives contact the Town Office, if enough people are interested he will arrange a trip.

Ann Marchand – Stated that on behalf of the Beatty Chamber of Commerce they are strongly in favor of exploring the donation.

Ann Marchand - Asked if there any PETT Fund possibilities.

An item will be placed on the October 27, 2010 agenda to further explore the interest in the Locomotives and possibly identify a committee to go view them.

b. Action Discussion and possible decision to identify and contact 10 people to assist with the Balloting and Counting at the Beatty Town Advisory Board Election scheduled for November 10, 2010 and all matters pertaining thereto. – Carrie Radomski

From the audience by show of hands - Shirley Harlan, Ann Marchand, Debbie Baker, and Amina Anderson volunteered.

TS - Stated Jonnie Jarvis told her she would volunteer.

Shirley Harlan - recommended contacting last year's volunteers.

c. Action – Discussion and possible decision to acknowledge Emergency Service Volunteers Quarterly and all matters pertaining thereto. – Teresa Sullivan

TS - Explained this would be a way to maintain current Emergency Services Volunteerism and possibly improve it; Discussion followed.

KH- Motioned to have a Quarterly meet and greet with refreshments from 5:30 to 6:00pm posted, place an item on the agenda to formally acknowledge them for progress or certifications, etc. Annually have a Town barbeque at the park to acknowledge them:

KH- Asked if the Quarterly meet and greet would take place at the first meeting of the first month of the quarter.

TS - The first meet and greet would most likely take place in January 2011; recognizing October, November and December 2010.

d. Discussion and possible decision to solicit an RFQ (request for qualification) for feasibility study to build an independent center for emergency care, and all matters pertaining thereto. – Teresa Sullivan

TS - Handed out a list of the deficiencies of the Beatty Medical Clinic that were identified by Samantha Brashear who was with Beatty Health and Welfare at the time, February 2010; Discussion followed.

TS - Referred to a survey sent out, about the medical facilities and services available in Town, in April 2010. 74% of respondents agreed the Beatty Medical Clinic should be upgraded to an independent center for emergency care; which would require having a physician and registered nurse on the premises.

TS - Spoke with the County, Pam Webster, her recommendation was to have a feasibility study done; Discussion followed.

TS – Clarified that a RFQ (request for qualification) for a feasibility study will not cost the town anything, later a decision would need to be made to pay whatever the cost is to complete the actual feasibility study; Discussion followed.

KH – Motion to solicit an RFQ for feasibility study to build an independent center for emergency care and all matters pertaining thereto; Second TS; Discussion followed.

EG - Expressed concern about submitting an RFQ prematurely; Discussion followed.
