## I. Beatty Area Plan

DG – Stated that the group met last month and started working on maps, and are hoping to have something for the public to comment on after the first of the year. The next meeting is tentatively scheduled for Monday October  $22^{nd}$ .

### IX. Beatty Medical Clinic

### XIV. Desert Hills Cemetery

Carrie Radomski – Stated there was one item on the agenda at the last meeting; to approve a location for the VFW to bury retired flags. A space was selected by the Sexton, Fred Willis, and was approved by the Committee.

## XV. Emergency Services

Chief Harmon – Reported there were 12 calls last month with good response; three vehicle accidents; 2 MVA's and the plane crash. Six responders to the MVA's and eleven responders to the plane crash with most of the ambulance crew. Work has started on the old building door removal and brick install. Work should begin on the bathroom in two weeks.

Vance Payne Nye County Emergency Services Director – Stated he was in the area last weekend to support Mike and Allison during the Tough Mudder event. He was very pleased with Beatty Fire and Ambulance they stood up to just the right level. The Tough Mudder people run a quality event, there were some issues prior to the event with State of Nevada licensing requirements for their onsite EMS people, but they were resolved. This will not be an issue for future events. Nye County does not typically have events of this size, we learn as we go.

EG - Asked if Vance saw the event packet they submitted prior to having the event here.

Mr. Payne – Said he did and was a professionally done, a very good plan. This plan has been tested and was really good, he was really pleased.

Mr. Payne – Stated he understands we have plans to hold an emergency preparedness workshop and would like very much to attend it.

Mr. Payne – Stated the County has completed a hazard mitigation plan and for the first time ever he will be taking it out to the Town Boards and he would like to discuss it with them, it will take about 15 minutes. The plan is a large document but it has been condensed to a one page bullet point reference sheet.

Mr. Payne - Recognized the Beatty Volunteer Fire and Ambulance services for their response and performance at the plane crash that occurred on October 2<sup>nd</sup>. The crash took power lines out which caused a town wide black out for over 12 hours.

Mr. Payne – Also recognized the BTAB for its response to the situation; contacting him and meeting at the Community Center to act as an information hub.

Mr. Payne – Stated the within an hour and a half we knew that we did not have an emergency situation, we had an inconvenience.

Mr. Payne – Stated that many things were learned during and after this event and it has given us a good foundation to start with.

#### XVI. Ordinances

Carrie Radomski – Reported that the BVFD ordinance has been sent to Human Resources for final review and the ordinance should be on the second BTAB meeting agenda in October or the first meeting in November.

### XVII. Secretary

Carrie Radomski – Reported monies collected for services performed by the Town Office and sent to the Nye County Treasurer for the month of September 2012:

Notary - \$75.00; Photo Copy - \$10.90; Fax - \$5.00; Community Center Rental - \$30.00; for a total of \$120.90 credited to the Town Accounts.

Ms. Radomski – Stated the most recent Nye County Population estimates have been received, if you would like a copy let her know. Beatty's current estimate is 1037 this number is based on an equation using the number of power hook ups. The report is provided by the Nye County Department of Planning in Tonopah.

Ms. Radomski – Stated she completed a survey of the local business regarding the impact of the Tough Mudder event this past weekend. If anyone would like a copy please let her know. In summary the responses were positive with most businesses seeing a lift in customer traffic.
