RR - Motion to approve Town Vouchers in the amount of \$564.76; Second CT; 4-0

9 General Business

- a. For Possible Action Discussion, deliberation, and decision to 1) request qualifying needs form Nye county Sheriff's Office Beatty Substation, the Beatty Volunteer Fire Department and the Beatty Volunteer Ambulance Service and 2) to submit budget recommendations for public safety tax funds to the appropriate department heads and or the Board of County Commissioners and all matters pertaining there to. Erika Gerling
 - DG Stated that this was an item that was tabled from October 13, 2014.
 - RR Motion to accept supplemental information; Second CT; 4-0
 - EG Stated we've had this on the agenda a couple of times but we didn't have all of the information we needed to proceed. This has to do with the sales tax that is for our fire, sheriff's office and public safety. I reached out to everyone except the sheriff's office, because now that we have a new sheriff coming in, it's probably prudent to wait. I did receive from Allison, the Volunteer Ambulance Service Coordinator, correspondence. Even though it (the ordinance) does not specifically mention ambulance I feel that they're a part of our public safety.
 - EG Read Allison's and the Fire Chief, Mike Harmon's correspondence.
 - EG Stated she would like to draft a letter to send to Vance saying this is what our departments would like and when you are ready to submit your request, because they can only do it annually to the Commissioners, to let us know so we can support his request if it includes what our departments want. My only reason for not sending it to the Commissioners right now is because I don't want to get in front of Vance; I want to be a united front when he submits his request. I don't have a problem involving the Ambulance department; I know that the BTAB has spent over sixty three thousand dollars on the Ambulance Barn.
 - CT Stated that at the last meeting (BTAB) Commissioner Wichman attended she explained that we could pool the money with another town. I'd like to see us talk to Amargosa and pool with them and get another deputy that would cover Beatty and Amargosa. We have one deputy that covers from here to Crystal and if they have an arrest they have to drive to Pahrump; Discussion followed.
 - EG Stated when Rick Marshall was campaigning he said he wanted to get one dispatcher back in Beatty.
 - EG Stated this is supposed to be a three year ordinance, there is a sunset clause in the bill draft, I don't think this should go away.
 - CT Stated in regard to the dispatchers, the two former (Beatty) are now back to being dispatchers in our Beatty office. They are discovering that it didn't work out as far as saving money.
 - CT Reiterated find out from Amargosa if they are willing to pool their money with us to get a deputy with those funds.
 - DG Asked if there is anybody staff knows in Amargosa they could call to talk to them about this.

Carrie Radomski; Town Secretary – Stated she will make a phone call to the Amargosa Town Office.

- EG Stated then the next thing will be is to not let this expire, because then they (the Sheriff) will have to budget for this position and really if you saved all of the money for three years it may not be enough for one deputy. Just for a dispatcher it is about seventy thousand dollars per year.
- EG Motion to send a letter to Vance Payne EMS director with the budget recommendation for the Public Safety Tax Funds; Second CT; 4-0
- DG Stated he spoke to Assembly Man Oscarson, at Beatty Days, about the Ambulance Barn status. He agreed to look into it.

b. For Possible Action - Discussion and deliberation to send a letter to the Bureau of Land Management about the Burro problem in Beatty. - Randy Reed

- RR Stated he placed this on the agenda because he's had several people come up to him and complain about the burro problem in town; BGID, the manager at the Senior Apartments, and some neighbors about the burros bothering dogs. North of town there are very large herds.
- EG Stated it has only been about two years since the last roundup and the population has exploded. Also, people are stopping on the highway and making u-turns to take photos of the burros. I understand that everybody likes the burros but the population is too big.
- DG Suggested sending a letter to Tim our BLM representative; Discussion followed.
- RR Motion to send a letter to the BLM office in Tonopah about our concerns about the burro problem in Beatty; Second CT; 4-0

For Possible Action - Discussion and deliberation to approve up to Three Thousand Dollars (\$3,000.00) to refurbish the Beatty Mural and all matters pertaining thereto. - Beatty Town Office; Carrie Radomski

Carrie Radomski; Town Secretary – Stated she placed this item on the agenda because we are doing some lighting work on the mural and it is a unique thing for Beatty, it's a great piece of artwork and it's something we are really proud of, but it does need some refreshing. Laura Cunningham the original artist responded to our request and agreed to touch up the mural. The cost estimate is around three thousand dollars; Laura provided us a sample invoice which shows labor and some materials at two thousand five hundred dollars. There is also a list of the paint she recommends we purchase for this touch up project, which is a high quality fade resistant paint. Laura will be able to begin work in December.

DG – Stated it's a great mural. As you know we are in the process of putting in lights, will that interfere with your work at all?

Laura Cunningham - Stated no not at all.

EG – Stated that in 2007 when this agreement (to construct the mural) was made there were stipulations in there that at some point there would be maintenance and up keep: Discussion followed.

Albert Verrilli - Stated I would like to know what the nature of the deterioration is?

Ms. Cunningham – Stated the specific black pigment faded in our desert sun. The blues, reds, and yellows are very light fast but the sun faded the black so I'm going to choose a black pigment called carbon black which doesn't fade and hopefully it will rectify the fading problem, particularly on the train. The south facing wall is the worst location for a mural, southwest facing. It's just the elements, sun and rain.

Mr. Verrilli - Asked if there was a UV coating on the mural.

Ms. Cunningham - Stated there is, but we have quite a desert sun here.

RR - Motion approve up to Three Thousand Dollars (\$3,000.00) to refurbish the Beatty Mural; Second CT; 4-0

DG – Stated the Veterinary Students sent us a photo of them by our reader board that advertised their visit here. The students really worked their tails off.
