Marty Campbell - Stated I want to make a few comments about the center. We have a new site manger in there that's doing a real good job, the cooks are doing a good job and we're getting along in there pretty well right now, but we're still fighting a couple of individuals.

Mr. Campbell – Stated I was up here a couple of years ago trying to get this going at that time but I didn't have the support that I have now. We've got Vonnie Gray, Patti Butler, Jerry Martin, myself, Randy Reed and Mike Watkins. We've got our Board made up already, we've had numerous meetings, we've gone through stuff, we've got three updates on our by-laws. We have our last meeting tomorrow for our final rendition of our by-laws and our articles of incorporation. Then we'll have that sent of and hopefully we'll be able to get the information we need from the IRS at that time and we'll start working on the next step in the process of getting this done. I want to thank, especially, Vonnie and Patti for all of the work they've done so far. We had a meeting last Wednesday in Amargosa with the individuals that helped set theirs up Diane and Gene Adams and that went real well. We got a lot of information from them about the next step that we're going to need to take. We are going to be meeting with Carrie to talk about what we need to do as far as the building goes. We are moving in the right direction and that's why we are asking for this money so that we can continue on.

DG - Asked is this for the filing fees?

Mr. Campbell – Replied yes and whatever else we need to do. Amargosa, they took quite awhile to get through theirs and they finally had to break down and hire a lawyer to do theirs. They ended up editing their documents and the process went much quicker. We can't do anything with grants until we get this done; discussion followed.

RS - Asked, where would this money would come from?

Carrie Radomski; Town Secretary – Stated I would suggest Admin General.

EG - Agreed, yes.

Vonnie Gray – Stated one of the things it's really important for us to also realize is without saying names, we are going to need to do some massive fund raising for us to get a bank account started, because part of the whole thing is having enough money to have a budget. Patti and I are working on budgeting and we're using numbers from Amargosa, we have tried to figure out numbers from the Tonopah people and this is where we're going to be asking Carrie for help to see if she can figure it out... but we cannot figure out at all where the money is going or what money is for Beatty. It's like the money is in these little pockets of somewhere and we might end up ruffling some feathers but we just need you guys to know our seniors here are really important and I told Marty that once I retired that this would be my next take on. So, I have retired so this is my next take on but there are a lot of different variables that we will need to go through just to get our licensing and all of that tax stuff, it's not going to be over \$1,000.00; Discussion followed.

DG - Clarified if someone is going to make donations will it be earmarked for the new entity?

Mr. Campbell - Replied yes; Discussion followed.

Ms. Gray – Said we will need roughly \$40,000.00 to start but we still have to review employment, utilities, transportation and other costs; Discussion followed.

EG – Stated for right now what I would say is that the costs associated with filing and obtaining this 501c3 status is what we should do.

DG – Asked would you like to make a motion?

EG – Motion to approve up to \$1,000.00 to cover costs associated with the Beatty Senior Project Council filing and obtaining their 501c3 and all other documents that may be required up to \$1,000.00; Second PF; 5-0

10 General Public Comment

Dottie Harmon – Stated I wanted to tell the VFW it was great to see all of those people here, it was great.

Rupert Bragg-Smith – Stated you know I go away every summer racing and when I come back I see the change in Beatty that maybe you don't if you live here all of the time and what I see is more and more cars on blocks, stripped, trailers just left, and described more areas with trash. I think we as people that live in Beatty need to be cognizant of that.

DG - Stated I agree but that's something that is set by the County.

RS – Stated I was talking with Mike (Chief Harmon) about this. I've been trying to contact the owners of the properties. According to the NRS the property owner is supposed to have those things removed at their expense. If it's on Nye County property then it's up the Sheriff Department that has to remove them at their expense. The property over here by the community center is privately owned and the property owner does not want to move it because it's a cost to them.

Mr. Bragg-Smith - Asked can we not have a town ordinance?

RS – Replied, there is already an ordinance for it. It's the code enforcement issue that of getting the code enforcement people down here to deal with it.

Mr. Bragg- Smith – Clarified, it's not enforceable by the Sheriff's Office?

RS – Replied, no the Deputies are more for the law enforcement and then the code enforcement is for the code part. So that's where the issue has been and that's why I'm trying to work with Brett. That meeting that you guys had was really good, I got a lot of good information from Brett, so I'm going to start working with him on trying to see if we can get this fixed; Discussion followed.

EG – Invited Mr. Bragg-Smith to help us as we work on our documents; Discussion followed.

Mr. Bragg-Smith – Stated I looked at a piece of property in Lebanon, it was an old homestead on 30 acres in Oregon and I found out I had to do this, and this, and this and the property was phenomenally expensive and I just said I'm not going to pay \$10.00 for an apple and have you tell me how to eat it so I said I'm going back to Beatty because, no we don't have all of these ridiculous rules and the hands aren't always out, we can basically do what we want, we can build what we want and we can enjoy our life without all of these ridiculous rules but we have to have some law as they say.
