Dr. Scoccia; Nye Regional Medical Center – Apologized for the suspension of operations in Beatty. Dr. Scoccia explained that Nye Regional is a nonprofit corporation and a little over a week ago a large client pulled all of their lab work and gave the business to Quest.

Dr. Scoccia – Stated that this is a temporary suspension of operations; they have invested five hundred thousand dollars in Beatty. The van and prescription outreach services are still in operation for Beatty, and they anticipate resuming the clinic services in Beatty in 60 to 90 days.

David Spicer – Reported that since the last meeting discussing the riverbed clean up; getting agencies involved, continued community support for the continuance of the Amargosa Toad and the habitat management that will keep it of the endangered species list, significant advances have been made, and as soon as they are ready they will present to the BTAB, what is necessary as far as possible cost. Matching funds are considered for Federal grants. There is a meeting scheduled tomorrow with the BLM and funding has been secured through several grants from agencies such as; the EPA, US Fish & Wildlife Service, the Nevada Fish & Wildlife service, for work that will be done in the river corridor, which is north of the Stage Coach and even to it. Progress is being made.

Mr. Spicer – Stated that he is the contractor on record for the Vegas to Reno Race, and is responsible for the all of reclamation of the public lands used for the race.

# 6 Presentation - Comfort Hospice Care; Wes Clouser

Wes Clouser; Comfort Hospice Care – Stated that Comfort Hospice care has been serving patients in Beatty for about a year and a half, they currently have four patients in Beatty. Comfort Hospice Care's main office is in Las Vegas, with one office in Pahrump, it is in the process of being licensed.

Mr. Clouser – Introduced himself, and the four goals of Comfort Hospice; pain relief assistance, family support, patient empowerment, and assisting the patient and family with being at peace with end of life decisions. Our goal is palliative care not curative; it's for those that have a life ending illness. Weekly Nurse and certified nursing assistant visits up to 5 times per week; house calls are made by doctors.

Mr. Clouser - Went on to state that anyone can be referred to hospice by anyone, it does not need to be family, and that the main payer of hospice services are Medicare and Medicaid, typically Medicaid will pay 100% of the cost.

Mr. Clouser- Stated a common question is; what happens if a patient shows signs of recovery?

Mr. Clouser – Stated that when that happens the patient is evaluated and if they do not qualify for hospice care any longer, they are referred to a home health care service.

Mr. Clouser – Stated that volunteers are always needed, and anyone can contact him if they are interested in volunteering or if they have any questions about the services provided.

DG - Recognized Commissioner Eastley and Pam Webster the Nye County Manger in the audience.

EG – Stated that the Little League Skills Practice program started yesterday and only two kids showed up. The practice starts at 6:30pm on Tuesdays, Wednesdays, and Thursdays and she invited the community to come and participate.

DG – Stated that the Town Office has received word from the Treasurer's Office that the Phoenix/Atomic Inn has paid all back taxes and fees and is now current. Representatives from the CCSN Veterinary College will be here on Wednesday July 11<sup>th</sup>, flyers are on the back table. The Skate Park's type 2 base is in and compacted, concrete is scheduled for the 3<sup>rd</sup> week in July and ramp installation is tentatively scheduled for July 30<sup>th</sup>. The Town has been invited to present both the Town Square and the Habitat Trail Projects on August 6<sup>th</sup> in Las Vegas, we will be presenting to the Statewide Transportation Technical Advisory Committee. Torn with NDOT reported that all curb, gutters, and commercial driveways are expected to be completed and open by Monday July 2<sup>nd</sup>, the road bed modification is planned to start on Monday July 9<sup>th</sup>, on the north bound side of HWY 95 starting at the "Old General Store" and ending at Beech Street. The southbound traffic will be detoured up Beech to Rebel to 3<sup>rd</sup>, exiting on southbound 95 by the Death Valley Inn.

Carrie Radomski – Stated there is a public hearing set for July 17<sup>th</sup> at 10am, for Nye County Code Title 6; Animals. The hearing will take place in Pahrump, but it will be available to the public via video conference at the Beatty Justice Court. Ms. Radomski – Spoke about a new flyer for Beatty, it is part of previous EDA grant for Nye County economic development, to create an electronic flyer that will be used on the County Website and can be used on other sites and outlets. It is designed to promote economic development and tourism. The flyer was created by BEC Environmental in cooperation with the Town and the Chamber.

All the hotels/motels are sold out starting on Friday night the 16<sup>th</sup> of August; the event is the 16<sup>th</sup> through the 18<sup>th</sup>.

Mr. Folks - Presented the Town with a certificate of liability and presented Beatty High School and the Beatty Volunteer Fire Department with donations of \$500.00 each.

Mr. Folks - Stated he has a schedule of events if anyone would like to review it; Discussion followed.

Mr. Spicer and Mr. Hunt – Explained the road reclamation process and the ongoing improvements to the staging and execution of the race; Discussion followed.

KC - Asked if they are bringing their own medical.

Mr. Folks- The information is not his packet but stated they will; Discussion followed.
