 For Possible Action – Discussion, deliberation and decision to spend up to \$20,000.00 for three radar speed signs that will notice drivers of their speed and to slow down if they are driving in excess of the posted speed limit. – Beatty Town Office; Carrie Radomski

Carrie Radomski; Town Secretary – Stated the residents had expressed concern about speeding and the running of the stop sign on Highway 95 in the center of town. The BTAB has sent correspondence and met various representatives from NDOT about these concerns. In fall/winter 2018 NDOT agreed to install and maintain the signs if the Town would purchase them. Three signs are on the agenda with the thought that they could be placed on the three points of entry to Town. NDOT has recommended the RU2 Fast 375 sign from ru2systems. In your packet there are quotes from other vendors, none of whom can supply the sign that is required by NDOT for posting. I put them in there so you can see the pricing and what is available. I've been working with Sami from NDOT and he requested that the signs do have that flash to slow down. It will tell you what your speed is and if you're over the limit, over 25mph, it will flash slow down. This is a piece in trying to address some of the residents' concerns.

EG - Asked will we need to have an MOU or something with NDOT.

Ms. Radomski – Stated, I've emailed several people and I haven't heard back yet but I'm sure once I submit an agenda request we'll get all kinds of things.

EG – Stated okay, that's what I was thinking. I really like these signs and I like this company. I've spoken with them before when I was looking at the speed trailers and they sound like a good company.

DG - Stated I think it's needed.

Unidentified Audience – Asked are the permanently installed.

DG - Replied they are permanently installed.

EG - Stated they are solar and they are LED lights; Discussion followed.

EG - Stated one of these it says no subscription, do we...

Ms. Radomski - Stated no, we are not doing any traffic data gathering.

b. For Possible Action – Discussion, deliberation and decision to submit written comments to the Nye County Board of Commissioners, in support of, or opposing a bill to amend Nye County Code Section 15.17.060, minimum standards for Manufactured Homes. Public hearing scheduled for February 5, 2019, comments du by January 15, 2018. – Beatty Town Office; Carrie Radomski

Carrie Radomski; Town Secretary – Stated on November 19th the BTAB submitted a letter of support for a bill draft proposing to amend Nye County Code Section 15.17.060 Minimum Standards for Manufactured Homes. A new draft has been submitted to the BoCC for approval at a public hearing on 02/05/29. Some language in the draft has been changed. The BTAB has the opportunity to submit comments on this new draft. In the old draft there was a section for waivers and special exceptions and it directed; the installation of any manufactured home more than 20 years old on the date in which it is affixed to the land shall require the approval of the Town Board applicable to the area of installation. This one directed the person reading it, shall means you have to, so they would have to come to the local Board and get approval for that exception because the home was older than 20 years. The new language says; the installation of any manufactured home more than 20 years old on the date in which it is affixed to the residential lot shall require the approval of a waiver application by the Planning Director. So they must go to the planning director. Then it goes on to state; when applicable Town Boards both elected and advisory may make a recommendation.

General Business 10b continued

So they shifted, in the original draft the direction to the person reading it was that they had to go in front of their local board to get the approval to put in something older than 20 years and now in the new language, this is the biggest difference, is that it is directing the reader to go to the planning department and the planning director will make the decision and the advisory board or local board may make a comment. That's the biggest difference in the two different drafts. They did add section c on this as well, which is; under no circumstances shall the placement of a pre-HUD mobile home, factory built home produced before June 15, 1976, department of urban housing and development, be allowed anywhere within Nye County. So, if it's older than 1976 regardless of how this language is written, whether it's the local board or the planning director, they cannot grant an exception for anything older than 1976, that was added as well.

- DG Asked do we know if when it says new placement, if somebody has an old mobile home on their property and they want to move it, does that mean they can't?
- RR Replied yeah.
- DG Stated what we have is a letter and asked Ms. Radomski to read the letter.
- Ms. Radomski Read the draft letter; Discussion followed.
- RR Motion to submit the written comments to the Board of County Commissioners in support of the Manufactured Home code 15.17.060; Second EG; 3-0
- c. Carrie Radomski; Town Secretary – Stated at the BoCC meeting of 12/18/18 a public hearing was set for February 19, 2019. The planning department contacted us on December 13th requesting or review of the bill and any comments we may have. I notified planning that our first opportunity to consider this would be the evening of January 14th and that we would send our comments if there are any on the 15th. Planning said that would be fine.

- DG Stated we wonder why and asked Ms. Radomski to read the letter.
- Ms. Radomski Stated just to clarify for the public this is an all new law, this does not exist on the books.
- Ms. Radomski Read the letter.
- DG Asked for questions.
- EG Stated I hope they table it to give us time. It's actually not a bad law but there are questions and one thing specific to us for the future. There's nothing in there about traffic, roads, highway noise any of that kind of stuff.
- RR Motion to submit written comments to the Nye County Board of Commissioners on the noise ordinance; Second EG; 3-0
