- **b.** Treasurer EG Stated since we have approved our budget and sent it in, I'm not going to report on that right now. I'm just going to wait until we get to the more official thing but if anybody has any questions specific about the budget, they can call me or Carrie and we're happy to answer them.

9 General Business

a. For Possible Action – Discussion, deliberation, and decision to approve the purchase of fireworks for the 4th of July 2020 display in the amount of \$14,000.00. Funding to be split 50/50 between the Beatty Volunteer Fire Department and Town Tourism funds. – Chief Mike Harmon; BVFD

Chief Harmon – Stated we're not going to be able to do the big show this year. We have not been able to get any raffle prizes at all, but I would still like to put on at least a small fireworks show for the Town to let them know we're still here and we still care.

DG – Clarified, this \$14,000.00 that's the normal amount isn't it?

Chief Harmon – Stated yeah, it's what we put in for before the quarantine took place.

DG - Stated, okay if you're not going to use all of the fireworks do you have a safe place to store them?

Chief Harmon – Stated yes Sir, we have our bunker up there for them, where we store them when they come in because they usually come in a month early.

EG – Stated I don't have any questions about the amount or the split or anything but Chief Harmon, if we get the fireworks can you guys safely deploy them and just do the display, or do you think that's going to cause too many people to go to the... well the Park is closed so... I mean if we buy them, I'd like you guys just to do the whole thing. What's the issue with that?

Chief Harmon – Stated nothing really, I was just thinking of saving money and we could use the rest of them next year.

EG – Stated we will vote but here's what I'm going to say. I think that right now especially it's very very important, if we can get everybody to stay home all day long and not do what we usually do and if we can give them the fireworks... I think we need that.

Chief Harmon – Stated okay.

EG – Stated that is what I would like to do. So, you will have to with whatever safety regulations, you guys have PPE but if we're going to buy them I want to use them and we need them right now, we'll need it for the people.

Chief Harmon – Stated that was my thinking there. I'll build flyers that say please stay in your car or adhere to COVID-19 restrictions, please.

EG – Stated you can stay home and see the fireworks; you can see them anywhere in Town. So, that's my feeling, I want us to do, our whole thing, it's so amazing every year what you guys do. I think that right now this is something... we're not eating watermelon, we're not having a three-legged race, we're not having the Cowboys, we're not having a parade, we're not doing any of that but people can stay home and we can give them the fireworks. Can you pull that off Mike (Chief Harmon)?

Chief Harmon – Stated I think we can. Tomorrow night we're going to have our first meeting in six weeks at the fire department. I'll get all of the Pyro's and we will definitely discuss it. We planned on putting on at least half of it, I mean what's the other half?

RR – Motion to approve the purchase of fireworks for the 4th of July 2020 display in the amount of \$14,000.00. Funding to be split 50/50 between the Beatty Volunteer Fire Department and Town Tourism funds; Second EG
